DIRECTOR OF REGISTRATION

E-Mail Report - Jill reported that she is currently trying to submit rec registrations to soccer ri and I am not being successful. I have emailed Barbara & hopefully she will help me out.

DIRECTOR OF COMPETITIVE

Information will be sent out for Spring registration very soon. Player passes that were created can be used for the Spring. Erik laminated the passes in house saving \$3 per player approximately \$450+ savings. Things are going smoothly with the competitive program, so far.

Indoor program e-mails will be sent out and there will be a sign up sheet at the concession stand.

Funding for the competitive program is hurting, Erik feels he can pay for the Fall expenses. Challenger coaching expenses will be harder to cover.

DIRECTOR OF COACHES

Karen reported that a couple of the recreational soccer coaches reaching out for help. Karen has helped out at a couple of practices and also ran a couple of scrimmages.

DIRECTOR OF REFEREES

Referee coverage is working out well. Referee fees should be increased for the recreation by 21%, would increase \$4500 to approximately \$5300 a year, motion was approved.

DIRECTOR OF FUNDRAISING

Heather submitted \$500 concession profits given to Sherri. Also CYSA received \$2000 for the Soderstrom's efforts from Pfizer

DIRECTOR OF SCHOLARSHIPS

Charlie reported that there are 3 teams registered (1 CYSA and 2 from Westerly), for the 3 v 3 tournament, with 5 teams from South and 3 or 4 other teams. Looking for 3 sets of pugs for the tournament. Also looking for volunteers for referees. Charlie will make a decision by next Tuesday, may postpone until later in the month maybe the 22nd. Competitive donated \$100 to the scholarship fund, 10% of raised funds, per by laws.
